1. Par 1, SO 236, this Hq, dd 28 Aug 44, pertaining to movement of Flt and Air Ech of 497th Bomb G p (VH) is amended as follows:

DELETE: The QM this sta will furnish subsistence and messing facilities under the provision of WD Cir 241, 43. FD will pay in advance to the train comdr funds at the rate of \$.06 per rat as provided by par 3b, WD Cir 341, 43.

ADD: WD Cir 260, cs, applies. No per diem at AAF Herington, Kans.

Personnel not required to accompany troops may be atzd to perform travel by POC provided that travel time in excess of that required for the movement of the unit involved is adequately covered by an approved lv of absence. If such travel is performed, the appropriate parts of AR 35-4820, as amended, and AR 605-180, are applicable.
